**QUESTIONS AND ANSWERS REGARDING THE FORMAL BIDDING  
FOR "THE LONG TERM PASSENGER CAR RENTAL  
(1 PIECE)  
to  
THE NATO MILITARY POLICE CENTRE OF EXCELLENCE".**

- 1. Do you allow for the possibility of replacing the car for another one (meeting the bidding requirements) within the 36-month term of this agreement?**

Below you can find clarification of our query concerning car replacement while this agreement is effective:

- a) a car has been replaced with a new one (the same make or other) fulfilling requirements provided in your specification;
- b) you would bear no cost for it;
- c) price would remain the same;
- d) a new car would be delivered to your venue and replaced for the old one. You would surely be notified of the fact beforehand, and we would conform to your convenient time;
- e) it results from the fact that currently we are not purchasing cars for a longer period of time than one year (12 months).

**Re 1)** We agree on car replacement during the term of this agreement subject to the following conditions:

- 1) The Lessor shall notify the Ordering Party of the intent of car replacement in writing 1 month in advance, by providing a detailed description of a make and technical parameters of the offered car.
- 2) The Ordering Party reserves the right to verify the offered car in terms of parameters, and the right to refuse the replacement,
- 3) Car replacement shall not affect the price of the agreement, and the offered car shall be characterised by the technical parameters stipulated in the description of the subject of order or better.

**2. Do you accept all-season tyre that are adapted to driving both in summer and in winter (in accordance with the Polish traffic regulations).**

**Re 2)** We do not accept all-season tyre. We would like to have summer tyres and winter tyres.

**3. Do car mats have to be made of rubber, and are they needed in the equipment?**

**Re 3)** Yes. In order to avoid musty smell. Besides, it is easier to keep the car clean, especially in autumn and winter seasons.

**4. Due to COVID-19, some part of our Board is currently in Germany. Therefore, I would like to ask if the documents could be signed electronically and then printed out?**

**Re 4)** The Ordering Party requires a handwritten signature of an authorised person on the agreement (also based on a granted Power of Attorney that shall be verified by the Ordering Party every single time). We allow entering into agreement in an electronic mode which shall bear a qualified electronic signature verified by a valid qualified certificate.

**5. Will you accept a car without factory tinted windows?**

**Re 5)** In compliance with the description of the subject of order, the rear window together with windows in rear doors shall be:

- factory tinted;
- or film certified;

- or equipped with curtain accessory.

**6. Will you agree to the possibility of renting a car in the whole of Europe or in the world in cashless payment as an additional bonus?**

**Re 6)** We allow this, however, we do not impose any requirement as such.
